### **National President's Report**

Over the last three years I have had the privilege of holding the position of National President.

During this time, as an Association, we have been able to build on the foundations laid by my predecessors and continue to consolidate the profession of Practice Management within the Primary Care Sector.

#### **ADVOCACY**

Advocacy at all levels of Government, collegiality and partnership with other Peak Bodies have become key functions for the Association.

This year the Ministerial Appointment to the Primary Health Care Reform Advisory group has and will continue past the original 12 month period into the new year meaning that Practice Managers are at the table contributing to the formulation of a system of Primary Care Reform that will be delivered over the next 10 years in Australia. This reform has as its focus access to care, workforce and sustainability of the Primary Care Sector.

This past week, 20 or so Practice Managers from across Australia have met with the Primary Care Division, Department of Health, to consult on the challenges that face us as Managers of Health Practices' that have as our core business the delivery of Primary Health Care Services – we as Practice Managers lead our teams to achieve awesome things and deliver optimum health outcomes for the Australian population. This is being duly acknowledged.

We have been part of the Primary Care Implementation Group led by Professor Michael Kidd in direct response to the impact of Covid, often meeting weekly at the height of the Pandemic. This facilitated a two way flow of information meaning that we had access to information for our members in a credible and timely way but also that we were able to feed back the many challenges that faced us daily as the goals posts shifted often on a daily basis.

AAPM continues to hold a position on the Stakeholders Consultative Group with Department of Human Services, acknowledging that Practice Managers and AAPM are critical stakeholders whose contribution is valued

We continue to work closely with the Australian Digital Health Agency contributing significantly to the integration of best digital practice into our practices – this year has seen a focus on our Specialist Practices.

#### **MEMBERSHIP**

Our membership growth has been pleasing this year, highlighted by the launch of our online community forum. This forum enables the connection of members across the whole of Australia and all disciplines. It is wonderful to see the depth of communication and sharing of information and lessons learned. Already there has emerged special interest groups with the forum and we look forward to this continuing to evolve.

Our members have benefited from the delivery of timely and accurate information flow in the everchanging year that we have had and I would like to thank the National Office staff for working long hours to ensure this occurred.

Of particular benefit to many were the resources of the AAPM HR Service, whether by individual contact or attendance at a webinar we were able to access up to date and accurate information regarding the complex HR issues we faced as the year unfolded.

I welcome all new members to the AAPM community and encourage that you avail yourself of all that is on offer.

Congratulations to our 7 CPM credentialed members in 2020 and also to the 5 AAPM members who achieved fellowship this year.

#### **EDUCATION**

By necessity, the planned program for the year had to be adjusted, but we have still delivered.

I would like to congratulate and thank the National Office team, primarily Miranda and our education consultant Fiona Kolokas on the success of the online offerings of the Practice Manager Workshop and especially the Practice Manager Education Day which was well attended and a great success.

Not only was the planned webinar program delivered as published, we were able to develop and deliver a parallel program that addressed the challenges of managing our practices during a pandemic which was extremely well attended and received.

We look forward where possible to returning to face to face events importantly the conference planned for Adelaide in October 2021.

#### **NETWORKING**

As Practice Managers this is something we do so very well and despite the need to go digital it has continued as a valued component of being an AAPM member I thank our State Presidents for their initiative in holding whole of state networking sessions that have ensured we stay connected despite isolation, lock downs and border closures.

#### **OPERATIONS**

I would like to acknowledge the work of our CEO Nicholas Voudouris who has guided the National Office team through these difficult times especially given they are all located in Melbourne and therefore faced significant local challenges.

Together, as a team, they have been agile and flexible, working endless hours to ensure we received the information and education we so desperately needed positioning AAPM to be the timely source of truth in the myriad of confusing emails and information that bombarded our inboxes.

I would like to thank my fellow Directors who have supported and guided the Association through this year of change and challenge, in particular Fiona Wong who has just completed 9 consecutive years as WA appointed Director with a great deal of commitment and integrity holding various executive roles over that time

Fiona we thank you for your diligence and commitment.

Most importantly, I want to acknowledge and thank you – our members Practice Managers have risen to the challenges they have faced on so many levels and have emerged as recognised risk management and change management leaders crucial to the delivery of optimum health outcomes for the communities in which you work and serve.

We have led our teams, day in and day out, without the luxury of working from home but turning up to our practices ensuring that our staff and clinicians were safe to do their jobs – adopting overnight a new way to deliver care via telehealth. Our Allied Health, Specialist and Dental practice members had a different set of challenges that threatened their very existence with theatre lists and non essential services cancelled. This past year has been like no other for our population and for our profession.

I am so in awe of how each of you have risen to the individual challenges you faced.

My wish for you all is that this years end will bring some well earned rest and a safe and happy Christmas season for you and your loved ones and that 2021 will be very different to 2020.

### **Chief Executive Officer's Report**

This year truly was a rollercoaster. One of the highlights of the year was AAPM's 40th Anniversary conference, held in October in Brisbane, the city where AAPM was born. The conference was a tremendous success, with the highest number of delegates ever at an AAPM conference, and excellent attendance across the many concurrent and plenary sessions. Feedback on the educational value delivered by the conference has been very positive, in particular from early career members. The conference also provided an opportunity to look back across 40 years of service to the healthcare community, and to celebrate AAPM's successes.

AAPM ramped up its advocacy and representation efforts this year, with a deliberate strategy to broaden our sphere of engagement and influence. Engagement included participation in the Primary Health Reform Consultation Group, ADHA National Digital Health Workforce & Education Summit, the Primary Care Data Quality Foundations project, the PHNs National Forum, the Health Care Homes Forum, CHF Members' Policy Forum and the DHHS Consultation on Expansion of Information Sharing and MARAM Reforms, among others, as well as increased engagement with a range of policy makers.

In January the AAPM National Office launched its Bushfire Help Line, which reached out to help Practice Managers affected by the unprecedented fires that raised large swathes of Australia. However, the challenges were not over. By mid-March the COVID-19 pandemic was well established and had caused Australia to close its international borders. The pandemic has

challenged us profoundly, not just in a professional sense but also personally, resulting in remarkable changes to the way we live. In the face of these challenges, Practice Managers (and workers across the health sector generally) are to be applauded for the way they have dealt with COVID-19 and its many impacts. I know that many practice managers are working under very difficult conditions and are finding this a stressful, tough year.

AAPM's education program refocused in March, switching to an all-electronic format and putting all of our energy into providing COVID-19-related information that can help support practice managers and their practices through this pandemic. Our webinars and support resources have so far concentrated on topics such as PPE and infection control, COVID-19 testing, the emergence of telehealth, patient flow and other matters related to helping practices survive in these difficult times. Our HR advisory service ran hot with high call volumes across the whole year.

One of our goals has been to bring clear, essential information in an easy-to-understand format to Practice Managers on key topics amid the deluge of information flooding the media and other communication channels. Members will have noticed an increased volume of messages from AAPM, particularly through our social media channels. Keeping useful information flowing has necessitated regular contact with Health Department officials, and AAPM has been communicating regularly with the Commonwealth's Principal Medical Advisor & Deputy Chief Medical Officer, as well as his State and Territory counterparts, to bring our

members timely, accurate information and advice.

Against this frenetic background, the Board has continued to move forward with a consultation process regarding updates and changes to AAPM's constitution. The Board is consulting with members regarding the proposed changes, designed to strengthen our association's governance into the future.

We will continue to support Practice Managers through these highly uncertain times, and are accelerating our plans to launch an online practice community in 2020 that will better equip members to support each other.







### **2019 National Conference**

The 2019 AAPM National Conference was held from Tuesday 01 October to Friday 04 October 2019 at the Brisbane Exhibition and Convention Centre in Queensland.

The overarching theme of the conference was "Waves of Change". Practice management is an ever changing environment and Practice Managers ride the waves of change as part of their everyday work.

With Dr Norman Swan as our Master of Ceremonies, the four day conference was filled with a variety of education sessions, including presentations from international and local speakers, an array of social activites and a unique exhibition display. The 2019 conference was also a celebration of AAPM's 40th anniversary.

The education sessions included keynote presentations from Mike Farrar, who offered an international persepctive on providing sustainable health and care services in the face of rising demands and costs, and we closed the conference with the incomprarable Ms Ita Buttrose who delivered a presentation of "a passionate life", concluding in a standing ovation from the audience.

There were 7 plenary sessions and 24 concurrent sessions held throughout the week. Topics included: finance, human relations, risk management, marketing and patient engagement.

The social program is a key element of the AAPM conference and provides an opportunity for all delegates to view the exhibition display and to network and connect.

Each afternoon from 5:00pm, AAPM hosts conference happy hour with our exhibitors. During this dedicated time, delegates and exhibitors were able to chat and connect in an informal environment.

### **Education and Networking**

Education and professional development for Practice Managers is a key element of AAPM's mission. Education is delivered via face to face seminars and workshops and online through the webinar series. In this financial year, AAPM commenced delivering face to face education events in the early part of the year, switching to virtual online delivery at the commencement of COVID-19 pandemic and for the remainder of the year.

The webinar series covered a wide variety of topics relevant to practice management, with the material ranging from learning designed for those in the early stages of their career, through to intermediate and advanced sessions. The hot topics prior to COVID-19 included human resource management, finance, business

and marketing. Presented by industry experts, the webinar series was well received.

Starting in March, AAPM introduced a dedicated **COVID-19 Webinar Series** that ran parallel to the main webinar series. This was free for members and ensured **AAPM** members were kept up to date with the very latest information regarding the pandemic and the community's response to it. Webinars were delivered by key industry experts, including the **Commonwealth Department of Health's Deputy Chief Medical** Officer, Prof Michael Kidd, and psychologist Dr Simon Kinsella.

Face to face education activities included the Practice Management Education Days, a series of Reception/ Admin Workshops and Practice Manager Workshops, particularly in regional locations. In March 2020 AAPM switched to delivery by virtual webinar.

Networking was also impacted as a result of the COVID-19 pandemic, however in a positive way as we saw Practice Managers come together to support each another like never before. Weekly "Peer to Peer Support Meetings" were implemented in most States, and members from metro, regional and remote locations were all able to connect, share and support one another through the unprecedented challenges of the pandemic.

The 2020/21 education and networking program will continue to include hybrid elements in delivering education and networking opportunities for practice manager across the country.
