This requirement does not apply to: children <12mths, patients under COVID-19 public health orders or COVID-19 positive eligible for antivirals and seeking PCR referral, in a natural disaster affected area, attending an Aboriginal Medical Service, receiving urgent unsociable after hours care, who are homeless, or receiving services for blood borne virus, sexual and reproductive health, pregnancy support, smoking cessation or mental health. 30/20 rule applies to telephone items
